## MEMO FROM THE MAYOR

I have been quietly listening to the banter that the upcoming election has created and for what it's worth, I want to address some of the issues. I have been on the Board for 8 years and have lived in Foxfield since 1997. I have had the pleasure of knowing all the former Board members who have dedicated their time and energy because they wanted to make Foxfield the best that it could be. There are many different opinions and philosophies among Board members, but together through hard work and compromise decisions have been made that I believe serve the best interest of the community and reflect what the majority of the community wants.

Standards have been adopted and when necessary at the request of the community, they have been reviewed and changes have been made. Our Municipal Code is always evolving. The wants and needs of the community are always changing. I believe this Board has been responsive to the needs of the community and is willing to listen and explore different options.

The Town was formed 22 years ago. Residents wanted to avoid the urban sprawl and maintain the wonderful rural lifestyle that makes Foxfield unique. That philosophy has not changed. There is still a very strong desire to maintain the rural atmosphere, the natural roadways and dark skies. There is also still a strong desire to not be over-regulated. I contend that we are not over-regulated and that our regulations are necessary and reasonable. I also believe that although our zoning designation is "rural" residential, we are a residential community and as such we need to be concerned with the welfare of our residents and protect their right to peaceful living.

**Why do we need regulations and how do we balance individual property rights with protecting the welfare of the community as a whole?** In a perfect world, there would be no speeding, no crime and all neighbors would be kind and considerate. Sadly that is not the case. Rules are necessary because there are always a few that simply don't care. If there are no regulations, then there is no ability to enforce. So, if your neighbor decides to use their back yard as a garbage dump or never clean their pasture and the smell prevents you from enjoying your property, or blast their stereo at midnight or light their backyard up every night like a stadium or have rusted junk cars strewn about their yard, or have piles of dead diseased brush that harbors rodents and snakes, and we have no regulations prohibiting this behavior, then we have no authority to intervene. The truth is that while most people are reasonable and respectful, there are those that just don't seem to care. And because of those that don't care, regulations are necessary. It has been suggested that neighbors should work issues out among themselves. I would suggest that if a resident cares so little about how their property is impacting those around him, a peaceful resolution is probably very unlikely. Interestingly, I have had discussions with a number of residents asking why we need all these regulations and in the next breath they ask if we can do something about the "eyesore" across the street.

Over the years, the Town has adopted the rural residential standards, has regulated things such as outdoor storage, accessory structures and fencing. The regulations adopted were not at the whim of the Board. They were in response to resident's concerns and adopted after many hours of study and discussion. And again, none of these regulations are in stone. If the majority of the community would like to see changes, the Board will always take a look.

**Why do we have code enforcement?** The Town has always had code enforcement on some level. In the early years, a Trustee volunteer was the Code Enforcement officer. As you might imagine, volunteers were few and far between and finally no one wanted to do it. The Town then hired an outside company to provide services. There are some very difficult cases that require the expertise of a professional. Some residents need a gentle reminder that they are not in compliance. However, most code enforcement deals with weeds. We are mandated through The Colorado Noxious Weed Act to monitor and control noxious weeds. Every year we put articles in the Communique, send letters, send emails, publish pictures and ask people to please control the noxious weeds on their property and yet every year, there are major infestations throughout Town. If left untreated, the weeds will go to seed and spread to everyone else's property. For as many complaints as we get from people receiving weed notices, I get an equal amount of complaints from residents who spend time and money to control weeds on their own property and don't appreciate their neighbors that don't. The weed notice from Code Enforcement is a reminder that the weeds need to be tended to. We are not trying to be the weed police and we are not unsympathetic. Last year was very difficult because of all the moisture. The Town was one of the biggest offenders, particularly in the open space. We are working on the issue and have changed divisions within Terracare with the hopes that the open space maintenance will improve. We ask that residents please monitor their properties and if noxious weeds are present, pull, mow spray or use whatever method you choose to control them.

**Why should we care about property values?** For most people, their home is their largest asset. The equity can pay for home improvements, a child's college education, a wedding. It can allow an elderly person to do a reverse mortgage so they can stay in their home, it can provide money for assisted living or medical expenses. It provides money for retirement. The list goes on and on. We claim that we are unique because we are a community that cares about its neighbors. So to say that it is nobody's business how one keeps their property or how it impacts their neighbors is selfish. We do not live on 35-acre lots. Everyone's property is impacted by their neighbors.

In conclusion, this Board and the Boards before have worked hard to create an environment that maintains the rural atmosphere while trying to respond to the desires and needs of the residents. It is impossible to please everyone, but I do believe that we try our very best to listen to everyone's views and make decisions that we feel will have the most positive impact on the community. I applaud those that have come forward with constructive criticism and ideas on how to make things better. I would encourage everyone to educate themselves on the history of the Town- where we came from and how we got here. And I would respectfully ask that we keep our focus forward thinking and positive.

My name is Dave Goddard and I have been fortunate to have had the opportunity to serve the Town of Foxfield as Trustee-at-Large for the past four years. I am seeking re-election and would like your vote and another opportunity to serve.

My family and I moved to Foxfield from Arizona six years ago and love the rural atmosphere, our friendly neighbors, and the magnificent views of the Front Range.

I grew up in Northern Minnesota and am a graduate of South Dakota School of Mines & Technology in Rapid City. I have been a champion for town residents who want to improve their properties. I spearheaded code changes that allowed completion bond waivers for residents that needed to work on their culverts and driveways in the town right-of-way. Before these changes, there was no option but to hire a contractor at substantial cost.

I am currently advocating for flat rate permits for common projects such as re-roofing rather than penalizing a resident that wishes to use high-end materials with a permit fee that is a percentage of the project cost. I also support the ongoing development of published checklists that can be used by our residents prior to starting any project in order to minimize permitting and inspection costs.

I look forward to continuing to serving you and preserving this oasis of country living that we are so fortunate to call our own.



On April 5, 2016, you will have the opportunity to elect three fellow residents to fill the role of Trustee-at-Large for the Town of Foxfield. This critical role is to represent the interests of residents of the entire Town (versus a Ward), and make decisions based on what the majority of residents desire, within the parameters available to the Town and its Board.

I have served the Town as a Trustee-at-Large for a number of years, and I am staunchly committed to serving in a capacity that will continue to make Foxfield unique and desirable. 

# Minutes - BOT Meeting

## December 10 2015

### Call to Order/Roll Call

The meeting was called to order at 6:30 p.m. at South Metro Fire Protection District Station #42 at 7320 South Parker Road, Foxfield, Colorado.

The Pledge of Allegiance was recited.

The following Trustees were present: Gordon Kenney, Brendan Johnson, Allyson Zoellner, Sky Yost, Stephan Aguirre and Mayor Lisa Jones. A quorum was present.

### Approval of Minutes

Trustee Johnson moved, seconded by Trustee Aguirre, to approve the November 5, 2015 minutes as presented. The motion passed by unanimous voice vote.

### Public Hearing

Mayor Jones opened the public hearing regarding the adoption of the 2016 Budget at 6:31 p.m. There being no public comment, the hearing was closed at 6:32 p.m.

### Resolution 2015-06, Adopting a Budget, Levying Property Taxes and Authorizing Appropriations for the Town of Foxfield for Fiscal Year 2016

Mayor Jones moved to approve Resolution 2015-06, Adopting a Budget, Levying Property Taxes and Authorizing Appropriations for the Town of Foxfield for Fiscal Year 2016. Following a second by Trustee Johnson, the motion passed by unanimous voice vote.

### Resolution 2015-07, Authorizing Supplemental Appropriations for Fiscal Year 2015

Trustee Kenney moved to approve Resolution 2015-07, Authorizing Supplemental Appropriations for Fiscal Year 2015. Following a second by Trustee Zoellner, the motion passed by unanimous voice vote.

### 2016 Terracare Associates Contract for Snow Removal and Public Works

Bill Winfield and Richard Prince with Terracare Associates discussed the snow removal process to date this season and clarified with the Board some adjustments to be made. Mayor Jones moved to approve the 2016 Contract with Terracare Associates for Snow Removal and Public Works, seconded by Trustee Johnson. The motion passed by unanimous voice vote.

### Reports

#### **Members of the Town Board**

Mayor Jones reported the Winter Fest will be on Tuesday, December 22 at The Dusty Boot. Trustee Johnson will provide hayrides through the Open Space.

Trustee Zoellner noted that the contractor did a good job with the shouldering project but she requested some form of protection for the pavement on the northwest side of the curve at E. Easter Way and E. Fremont Avenue. Trustee Johnson volunteered to install reflectors at that location. The possibility of striping was also discussed.

Trustee Aguirre requested an article in the next newsletter regarding safety, including such things as wearing light-colored or reflective clothing when walking in the dark.

Trustee Yost reported that she and Town Clerk Gallivan attended the Arapahoe County grants information meeting in November. Given the time frame for submittal of applications, the Board decided to defer any action until the fall grants cycle.

Trustee Johnson will look into building a "Little Library" box next to the central bulletin board at S. Richfield and E. Davies, where people can exchange books at no charge.

### **Staff**

Town Clerk Gallivan presented the November 2015 Treasurer's Report. Mayor Jones moved to approve expenditures of \$30,901.72, seconded by Trustee Aguirre. The motion passed by unanimous voice vote.

Town Administrator Kuechenmeister reported that she questioned the initial snow removal charges from Terracare Associates and they came back with an invoice that was substantially lower, with a reduction of \$4,354.75.

The meeting was adjourned at 7:36 pm.

### **Resolution 2016-02, Appointing a Designated Election Official**

Mayor Jones moved to approve Resolution 2016-02, Appointing a Designated Election Official. Following a second by Trustee Goddard, the motion passed by unanimous voice vote.

### **Study Session, Fences and Berms**

The Board discussed regulations and permit and engineering review costs for fences and berms. It was agreed the Board will propose amending the Municipal Code to simplify the process and lower the review costs for these permits. It was also agreed to consider charging a flat rate for a roof replacement permit. The specifics will be discussed at the next meeting.

### **Reports**

#### **Members of the Town Board**

Mayor Jones talked about structures in the Town's right-of-way and possibly requiring residents with existing structures other than mailboxes to obtain a right-of-way license and insurance naming the Town as an additional insured for liability claims. The Board discussed only allowing mailboxes in the right-of-way in the future but no decision was made.

Trustee Johnson noted he and his daughters are working on the Little Library box.

Trustee Zoellner raised the possibility of allowing sound walls for interior lots.

Trustee Yost noted she is still working on an on-line and/or print directory.

Trustee Kenney presented a spreadsheet showing year-end traffic volume and speed data from the two speed radar signs. He noted the need for some monitoring on week-ends. Trustee Johnson agreed to use the data for a comprehensive analysis of traffic patterns.

Trustee Kenney suggested the Town go back to mailing the newsletter to every resident. At this time, it is emailed to everyone on the email list and posted on the website and hard copies are placed in the box at the central bulletin board at Richfield and Davies.

Trustee Aguirre talked about snow removal. The Town and Terracare are still working out the parameters for plowing and usage of ice slicer.

Trustee Goddard noted that there have been no Centennial Airport noise complaints from Foxfield.

#### **Staff**

Town Clerk Gallivan presented the December 2015 Treasurer's Report. Trustee Goddard moved to approve expenditures of \$78,745.78, seconded by Trustee Aguirre. The motion passed by unanimous voice vote.

The meeting was adjourned at 8:32 pm.

## **Minutes - BOT Meeting January 21, 2016**

#### **Call to Order/Roll Call**

The meeting was called to order at 6:30 p.m. at South Metro Fire Protection District Station #42 at 7320 South Parker Road, Foxfield, Colorado.

The Pledge of Allegiance was recited.

The following Trustees were present: Dave Goddard, Gordon Kenney, Brendan Johnson, Allyson Zoellner and Mayor Lisa Jones. A quorum was present.

#### **Approval of Minutes**

Trustee Johnson moved, seconded by Trustee Aguirre, to approve the January 7, 2016 minutes as presented. The motion passed by unanimous voice vote.

### **Second Addendum to SEH Contract**

Trustee Goddard moved to approve the Second Addendum to the SEH contract detailing price increases for 2016. Following a second by Trustee Zoellner, the motion passed by unanimous voice vote.

### **Reports**

#### **Mayor**

Mayor Jones discussed the permitting process and possible ways to make it simpler and less costly.

#### **Members of the Town Board**

Trustee Zoellner reported she had a request from a resident for the speed limit to be increased to 30 mph.

Trustee Kenney requested a quick review of the steps for a commercial development application. Town Administrator Kuechenmeister responded:

- Public meeting for any landowners within 750 feet of the proposed development
- Submittal of formal application
- Review by Town staff and submittal of referrals to other agencies
- Response by Town staff

When the application is deemed complete, public hearings are scheduled prior to approval of the final development plans

Trustee Johnson presented a map of locations and photographs of potential "Mini Library" boxes. He estimates 6 boxes will cost \$200 to \$300 in materials. He and his daughters will donate the labor.

Trustee Johnson noted that he has had several complaints about snow removal. He also said the Open Space trail has not been plowed consistently.

### **Study Session**

At 6:23 p.m., the mayor opened the study session. The Board discussed permitting for fences, acceptable fencing materials and the allowable height of berms.

### **Executive Session**

At 8:00 p.m., Mayor Jones moved to go into an executive session to determine positions relative to matters that may be subject to negotiations, develop a strategy for negotiations, and/or instruct negotiators, pursuant to C.R.S. § 24-6-402(4)(e), regarding a contract with Terracare Associates for landscape maintenance. Seconded by Trustee Johnson, the motion passed by unanimous voice vote.

At 8:33 p.m., Mayor Jones closed the executive session and the Board returned to the regular meeting.

Mayor Jones adjourned the meeting at 8:34 pm.
